1. Storm Drainage Project

Mayor Feth asked CAO Fuller to share the information provided by TNT Canada Consulting (Tyler Brake).

CAO Fuller read the email from Tyler. Drainage concerns have been discussed with the residents on Bateson as well as the residents on the south side of the village. Additional details from south side resident to come, we can proceed as is and provide a change order if necessary. TNT Canada Consultants suggested proceeding; Bateson street work has been taken as far as possible until a signed RFP is in place. Then we can proceed with the necessary landowner access agreements. South side will be evaluated as the project proceeds. Tendering would change the estimated project timelines and costs. The original engineering estimate did not include tendering, it will most likely increase the overall project costs.

Deputy Mayor Debnam expressed we could do major portion of project on contract, where public works could finesse it after the big picture has been addressed.

Barry shared some history on the project. He shared his recommendations to complete the project, then finesse it after it's completion. Barry had in the past sloped the alley to the west, and it had appeared to work.

Peter concurred and has confirmed the information, as this has been discussed directly with Tyler. Discussion progressed regarding the project. As the project progresses, it would be expected to have daily costs.
