BY-LAW NO. 03.12 A Bylaw of the Village of Bittern Lake in the Province of Alberta, introduced for the purpose of amending Land Use Bylaw No. #339 to change the land use of Pt NW 30 – 46- 21 – W4 as shown on the attached sketch from A – Agricultural District to SH Small Holdings District all being located within the Village of Bittern Lake.

NOW THEREFORE Pursuant to the Municipal Government Act, Section 606, the Council of the Village of Bittern Lake duly assembled, hereby enacts as follows:

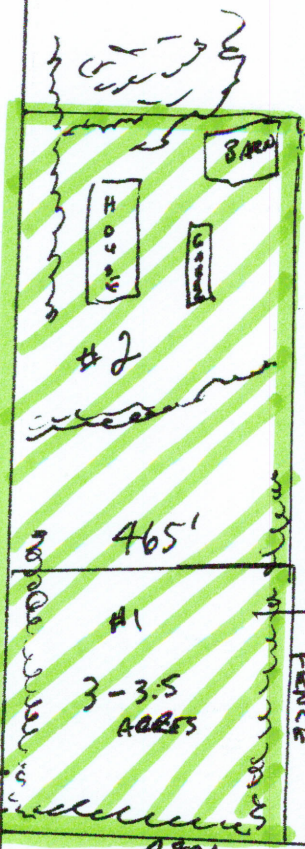

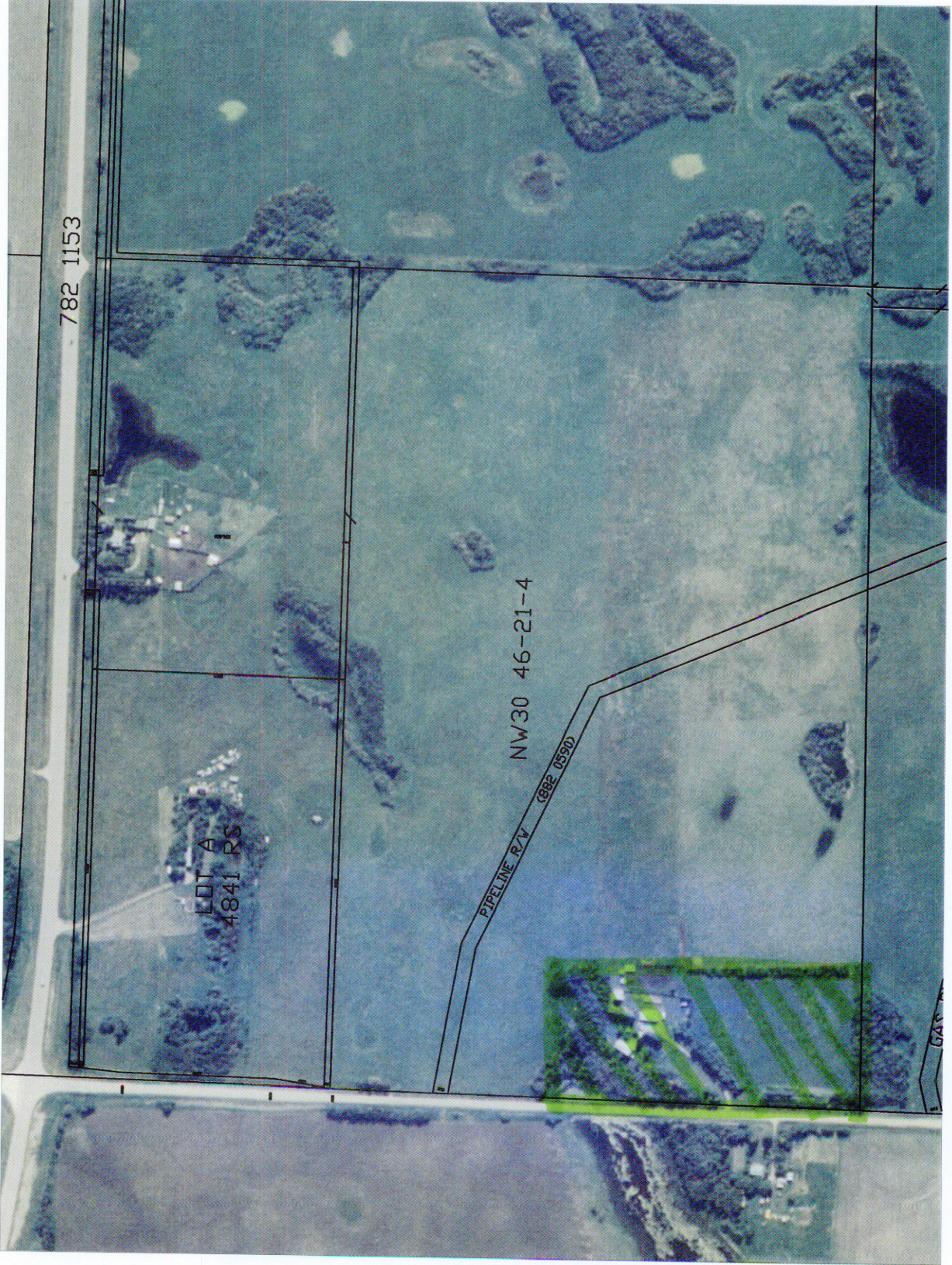
