The following charges are payable by the customer with the submission of this application:

1. Non-Resident Connection Fee..... \$12,000.00
2. City of Camrose Connection Fee..... Current cost
3. Application Fee..... \$100.00
4. Deposit on Water Meter..... \$150.00
5. Security Deposit..... \$100.00
6. Flow Controller & Backflow Preventer.....Current Cost

The following conditions apply to all hook-ups:

1. All work must be done by a Contractor approved in writing by the Village. It will be the responsibility of the Customer and their Contractor to ensure that:
  - a) The Contractor complies with all legislation and regulations including Worker's Compensation and Occupational Health and Safety or their successors;
  - b) The Contractor carries liability insurance in an amount of at least \$1,000,000.00;
  - c) In addition to any other regulations which apply, the Village's line must be exposed by hand-digging and any phone, power, or gas lines must be located and properly supported, before any machine excavation is done;
  - d) Customer or their Contractor must obtain any plumbing permit required under applicable legislation or regulations.
2. The Customer will give the Village at least two weeks advance notice of the date that any work is to be done and advise the Village of the date the connection is to be made to the Village's Water line. No work is to be done within the Right of Way until a Village representative is on site.
3. The Customer's Contractor will install, at the cost of the Customer, a one-gallon-per-minute flow restrictor and a back flow preventer. The Customer will provide and install a curb stop, and all other items required for the hook-up.

4. A representative of the Village will be present during the connection to the Village's water line, and the Customer will pay the Village's costs to have the representative present.
5. Water meter must be obtained from the Village, to be installed by a plumber approved by the Village, at the cost of the customer.
6. The Customer and his Contractor will be responsible for any damages caused as a result of the connection to the Village's water line. Such damages include but are not limited to: loss of water, engineering and Contractor's charges for the repair of any damage, legal costs, and trucking of water to the Village's reservoir. The Customer will also pay an administrative charge to the Village of 10% of the total damages.
7. Water meter will not be issued and water will not be supplied until all charges under #4, #5, #6 and #8 and all fees and deposits are paid.
8. a) All conditions to the Water Supply Line shall be completed in accordance with the Specifications on Schedule 1.

  - b) The Village will prepare design and "as constructed" drawings, and construct the water service hook-up using the Village's selected Contractors and Engineers;
  - c) The Village will prepare design and "as constructed" drawings, and will supervise construction of the water service hook-up by the Customer's Contractor;
  - d) The Customer will retain Engineer's to prepare design and "as constructed" drawings, and a Contractor to construct the hook-up. All design and construction work will be in accordance with the specifications.
  - e) The Customer will pay any Engineers or Contractors retained by them or the Village to design and construct the hook-up.
9. The Customer must notify the Village in writing, at least two weeks in advance, if they no longer require the water service. However, the customer agrees to pay to the Village, on a monthly basis, the Village's basic monthly service line charges. The customer hereby charges and encumbers all their right title and interest in \_\_\_\_\_ (legal description of land) to the Village as security for the aforesaid payment. If the Customer's water account has been paid in full and the water meter is still in good condition, the Village will refund the deposits paid thereon without interest. If the account is in arrears or the meter is not in good condition, the amount required plus any penalties will be taken out of the deposits paid and the remainder refunded without interest.

The Village may add any other conditions.

The supply of water is subject to the terms and conditions set out in the Village's Standard Water Supply Agreement. The Customer acknowledges having received a copy of that Agreement.
