Nomination Day & Elections Database Information

NOMINATION DAY - SEPTEMBER 22, 2025

Candidates were able to submit nomination papers as early as January 1, 2025, but must have them in by noon, September 22, 2025 (referred to as Nomination Day), in order to run in the municipal election.

New for this election is the requirement for candidates to submit their notice of intent to become a candidate. Candidates who have not already submitted this notice are required to do so at the same time they submit Form 4 – Nomination Paper and Candidate's Acceptance and Form 5 – Candidate Financial Information. Please refer to sections 147.22 and 147.221 of the Local Authorities Election Act (LAEA) for notice of intent requirements and disclosure.

Also new for this election is the ability of candidates to withdraw within 24 hours after the close of the nomination period (by 12 noon on Tuesday, September 23, 2025), even if this creates an insufficient number of nominations for that office (per *LAEA* s.32). If an insufficient number of nominations occurs this way, the municipality would be required to follow the process under *LAEA* s.31.

Please note that *LAEA* sections 31 and 34 have also undergone changes for this election. A nominations fact sheet explains these amendments in more detail and is located at <u>Local Authorities</u> <u>Election Act Change Summary: Nominations.</u>

Notice of Nomination Day

Section 26(1) of the *LAEA* requires returning officers to give notice of nomination day in the prescribed form (Form 3 of the LAEA Forms Regulation). This must be done by one of the following methods:

- publishing a notice at least once a week in each of the two weeks before nomination day in a newspaper or other publication circulating in the area;
- mailing or delivering a notice to every residence in the local jurisdiction at least one week before nomination day; or
- the method or methods for advertising authorized by a bylaw passed in accordance with section 606.1 of the *Municipal Government Act (MGA)* (if applicable).

If using one of the first two methods, notices must be published the week of September 8, 2025 and September 15, 2025, or mailed or delivered to every residence by September 15, 2025. Once notification has been provided by at least one of these methods, the returning officer may publish, mail and deliver additional notices, and/or give notice by any other method, as many times as considered appropriate.

Submission of Candidate Nomination Information

All municipalities are required to submit candidate nomination information by the end of business on Tuesday, September 23, 2025 through the Elections Database (EDB).

Municipalities may access the database through <u>MAConnect</u>, the web portal that provides external stakeholders secure access to Municipal Affairs' key business applications. Municipalities that do not have a stakeholder administrator will have to enter into a Stakeholder Agreement before requesting access to the EDB. To request a Stakeholder Agreement, please contact <u>MAConnect@gov.ab.ca</u> or call toll-free by dialing 310-0000 then 780-427-3895. All returning officers should contact their MAConnect Stakeholder Administrator to obtain access to the EDB.

Returning officers are encouraged to log into the EDB to enter the returning officer information located under the "Elections Details" tab and complete the Electoral System tab. Returning officers will not be able to enter candidates until these two tabs have been completed.

Municipalities can enter candidate information under the "Municipal Candidates" tab. Once the candidate nomination information has been entered, municipalities are required to finalize candidates within 24 hours after the close of nominations. A completed Candidate Nomination Information Form can be generated by using the "print" button on the Municipal Candidate screen. Finalizing the nominations in the database replaces the need to submit a Candidate Nomination Information Form.

Returning officers must ensure the names of the candidates that have been nominated and the offices for which they have been nominated are posted at the local jurisdiction office by 12:00 p.m. on Wednesday, September 24, 2025.

Note: School divisions must submit their candidate nomination information to the Deputy Minister of Education. Please visit <u>School board elections | Alberta.ca</u> for more information.
